EXPReS Board Members,

attached to this note are slides that cover some information that will be discussed during the upcoming Board Meeting. I hope that you can find some time to look through the slides before the meeting. We will ask the board to endorse the changes that are presented.

The project office has identified that some partners are spending more quickly than others. This comes both from historical spending patterns as well as information provided to the office over the past months. Additionally, some partners are requesting additional funds while other partners may not be able to expend their allocation.

One of our goals is to ensure that the project as a whole expends the full funds provided by the Commission. To do this, we are transferring funds to those partners who have both requested additional funds and have been claiming their expected budgets. We hope to avoid a situation at the end of the project where any portion of the Commission contribution can not be claimed because partners realize that they can not make eligible costs. Slide 10 'Budget- Original, P1/2/3 adjustments' (see below) identifies several adjustments to the budget.

Some of the data that we used to come to these conclusions are contained in the slide deck. Slide 6 and 7 titled "Eligible Costs- Projections" highlight the eligible costs as reported on Form C's for Periods 1 and 2. The Period 3 and 4 comlumns are estimates and approximations to help determine our adherence to budget.

Slides 8 and 9 "Budget Overview" identify three values. The first column, expected budget, is the full cost of the project to each partner. This value combines the European Commission contribution along with the partner's own contribution (matching). The second column identifies the Requested European Commission Contribution. The total of this column is the amount that the project office will distribute to partners. The third column is the amount of funds that have already been distributed to each partner.

The next column is the difference between 'Expected Budget' and 'Requested European Commission Contribution.' This value is the amount of matching funding each institute indicated that they would provide for the project through the original contract. The final column is the difference between 'Requested European Commission Contribution' and 'Distributed funds.' This value is the proposed amount of funding for each partner, excepting modifications in the budget and taking into consideration matching.
